

## **Terms and Conditions**

## Overview

Welcome to the **National Driver Training Centre** (hereafter referred to as NDTC). Here are our promises and expectations at a glance, followed by our complete Terms and Conditions. These promises are an overview only and you need to read the full Terms carefully before using this Site. By using this Site, you signify that you have read and agreed to our Terms and Conditions including our <u>Terms of Use</u>, <u>Privacy Policy</u>, and our <u>Cancellation Policy</u> ("the Terms"). If there is any inconsistency between this overview and the Terms, the Terms shall prevail:

#### Our Promises

- NDTC will not pass your details on to anyone without your permission. Check out our <u>Privacy</u> Policy for full details.
- When you give us permission, we may pass on your details to third parties where it is required to
  complete our obligations to you or where required by law. For example, if you book for a course
  that has Unit Standards, NCEA credits or driver licensing outcomes, your details will be passed
  to the relevant qualification's agency.
- You can cancel your connection to the Site or unsubscribe from emails at any time by following the opt-out link.
- NDTC has a duty of care to ensure that all reasonably practicable steps are taken to ensure the health and safety of any person involved in any NDTC activity.

#### Your Promises

- You must be 16 years or older to book tickets using this Site.
- If you use the Site for any purpose, including making a booking, you agree to the Terms and Conditions.
- You agree that if you cancel a booking within three working days of your course or event you will not be eligible for a refund. Check out our Cancellation Policy below for full details.
- You agree to bring the necessary correct documentation (such as birth certificate, driver licence, proof of pre-course learning or Unit Standard achievement eg. logbook) to any course or event, and you acknowledge that if you fail to bring the correct documentation you may not be able to complete the course and you will not receive a refund.
- If you are required to complete pre-course learning to achieve Unit Standards, you must have completed this before attending the course. Trainees who have NOT completed their precourse learning before arriving at the course will be given the option to leave the course and re-book onto another course. PLEASE NOTE: there will be no refund and the full course fee will be charged for any new booking.
- Please make sure you attend at the stated start time; if you are more than 15 minutes late you may be turned away and charges will still apply.



## Terms of Use

The Site is an online service provided by Manfeild Park Trust (MPT) trading as the **National Driver Training Centre**, also known as "NDTC".

(Also referred to as "us" and "our"). It is accessed through the website <a href="www.ndtc.co.nz">www.ndtc.co.nz</a>, also known as "the Site". Please read these Terms carefully. By using the Site, including booking, and buying a ticket on the Site, you are a "Site User" (also referred to as "you" and "your") and agree to these Terms. Site Users include people who are booking course or event tickets, view the Site or use it in any way. If you choose not to be bound by the Terms, you must not use this Site.

### General Terms and Conditions

Bookings made on this Site are sold by and subject to the following Terms and Conditions as well as any other conditions presented at the time of booking and shown on the ticket or invoice. Tickets are sold subject to the following terms and conditions:

- You must check course, event time, date, and location before booking and deem it as accurate.
   Should you need to make changes to your booking, please refer to our <u>Cancellation Policy</u> for more information.
- You must comply with any special terms and conditions listed by the Course or Event
  Organiser during the booking process. If you do not meet these criteria or comply with these
  Terms and Conditions, the ticket holder may not be admitted to the course or event and your ticket
  will not be refundable.
- For those courses or events that require correct documentation i.e., Drivers Licence, Birth Certificate, Logbook etc. you will not be able to complete the course or event or receive a refund if you do not bring the necessary correct documentation.
- Your sale is not complete until you receive a confirmation email from NDTC and have made any
  payment that might be owing for the tickets. If the course or event is cancelled for any reason by
  NDTC and no alternative is available, then a refund of your funds may be available. Please read our
  Cancellation Policy for more information.
- Any and all details, including personal details, shown on your Course or Event Registration Form can
  and will be passed onto the Course or Event Organiser and/or Tutor, Instructor or Mentor, who may
  or may not be an employee of NDTC. No personal details will be provided to any party, except the
  person who made the booking, the person whose details were entered, the agency responsible for
  any qualification you are seeking, the organisation that has funded the course or any other third party
  where disclosure of your information is required by law. No credit card details will be passed to any
  third party.
- For those courses or events that require you to operate a vehicle under instruction by a driving
  instructor, you must abide by NZ Road Rules. Any traffic infringements or fines incurred by you are
  your responsibility.
- You must be mentally and physically fit to undertake your role during the course or event. Drugs and alcohol are strictly prohibited. Specifically:
  - You will not take any prescription medicine or form of drug known to inhibit your ability to operate a motor vehicle safely
  - You will not consume alcohol within 12 hours before operating a motor vehicle



- You agree to notify NDTC of any physical injury or condition that may inhibit your ability to operate a motor vehicle safely
- · You agree to notify NDTC if these conditions change at any time during the course or event.

#### Health and Safety

NDTC has a duty of care to ensure that all reasonably practicable steps are taken to ensure the health and safety of any person involved in any NDTC activity. This includes when you are engaged in an NDTC course or event at any delivery location.

- MPT and NDTC will ensure it meets its duties under the HSWA 2015 in the provision and maintenance of a safe training environment, welfare facilities, machinery and equipment.
- By agreeing to attend an NDTC course or event you agree to follow all fair and reasonable rules and instructions of NDTC. You must also take reasonable care that your actions or inactions do not cause harm to yourself or others.
- Failure to follow NDTC fair and reasonable rules and instructions may mean you are removed from the course or event, and any further participation in the course or event will be at the discretion of NDTC.

### **Payment Options**

All bookings are to be paid by credit card unless prior arrangements have been made with NDTC. If you do not have a credit card or an existing account with us and you have made prior arrangements for payment, you will receive an invoice to pay via internet banking.

- If you have not paid by credit card as you book, your invoice will be due for payment within 2 days of booking, unless prior arrangement for payment has been made with NDTC.
- ALL course bookings must be paid in full prior to the start date of the course unless prior arrangements have been made with NDTC. If payment is not received as per prior arrangements late fees may apply. Please see our Cancellation Policy for further detail.
- Any outstanding balances will need to be paid in full before any course certificates will be issued. Course certificates will not be issued until payment has been received.

## **Credit Card Transactions**

If you are the cardholder and you dispute any charge on your credit or debit card related to any course or event booked through this Site, you agree to notify NDTC within 24 hours of the scheduled course or event start time. We will do our part to resolve any issues within a reasonable timeframe. You agree that NDTC will have authority fully equal to that of their suppliers in collecting amounts owed for bookings made through this Site from your bank/credit card company or through courts/collection agencies.



## Security Capabilities and Policy for Transmission of Payment Card Details

When you pay by credit card via this site you are passed to an e-commerce gateway provider. You will see the provider's name before you enter your credit card details. The provider is Windcave. You will enter your credit card details within the secure environment provided by the e-commerce gateway provider. When the provider makes these available, NDTC may store your cardholder's name and a masked version of your card number. At no time do NDTC store or have access to your complete card number or other card details. All providers are compliant with the Payment Card Industry Data Security Standard (PCI DSS). All communication between this site and the payment gateway is encrypted by 128bit Secure Sockets Layer (SSL) technology.

## Your personal "My Events" page

## Who does NDTC share your personal information with?

NDTC will not share the information collected with any third parties, except as required to administer the specific course or event you have registered for. For example, if you book for a course that has Unit Standards, NCEA credits or driver licensing outcomes, your details will be passed to the relevant qualification's agency i.e., NZQA, NZTA, ACC etc. You can choose which details you share at the time you register and amend them at any time on your "My Profile" and "My Contacts" pages. Everyone NDTC has contact with or collaborates with in running courses or events agrees to keep that information private, but NDTC cannot guarantee they will comply. The information may be hosted with a service provider. Transactional and promotional emails are sent through a third-party email system. This supplier can only see email address but no other details. Our agreements with the hosting provider and the third-party email service protects the information submitted from any unauthorised use.

#### How does NDTC use the information?

When you register for a course or event, show interest in a course or event, complete a form, or participate in any contest or promotion on the Site you provide information to NDTC. NDTC may from time to time offer service bulletins, special offers and other promotions. NDTC may also use the data to check your identity if you are having difficulties with any of our Site services and to retrieve information e.g., such as your driver's licence or NSN number, if necessary.

If you book for others and provide data about them, the data provided will be used for the purposes of the course or event you book for. If you provide contact details for them, they may receive reminders and other communication related specifically to this booking. They will not receive other communication from NDTC unless they have specifically signed up for it themselves. From time-to-time NDTC may aggregate booker and ticket-holder information, analyse trends, preferences, and demographics. #### How does NDTC use "cookies"?

"Cookies" are small pieces of information stored by your browser on your computer's hard drive. Cookies do not contain personally identifying information. They do provide details of your IP address, the computer platform that you use (e.g., Mac or Windows), the browser that you use (e.g., Google Chrome, Internet Explorer, Safari) and what domain you are accessing our Site from. NDTC operates a strict Postponement and Cancellation Policy.

# Postponement or Cancellation of an **Industry Course** (Class 2-5 Training or Endorsement)

Should you wish to postpone or cancel your attendance on an Industry course or event, the following applies:

- Notification of any postponement or cancellation of course attendance must be made in writing to info@ndtc.co.nz
- If postponement or cancellation is given with more than seven working days' notice before the course or event date, the ticket buyer will be offered an alternative course or event date. A minimum \$50 transfer fee may apply for changes to booking dates and added to the new booking. If no acceptable alternative dates are available to the ticket buyer, then a refund of full course fees less a \$50 administration fee may be given. All refunds are made at the discretion of NDTC.
- If notice is given with less than seven working days and greater than three working days before the course or event date, 50% of the course fee may be refundable. All refunds are made at the discretion of NDTC.
- All postponements and cancellations within three working days (including non-appearance or non-completion of the course or event) will result in full course fees being charged.
- If a client arrives to a course or event and is not mentally and physically fit to undertake their role during the course, NDTC reserves the right to cancel the booking. In this instance, no refund will be provided, and rebooking may be done on a case-by-case basis.
- If a client arrives more than 15 minutes late, they may be turned away and charges will still apply.
- A refund of NZTA application and/or testing fees, will not be provided in the instance that a ticket buyer does not provide correct documentation (such as driver licence) or fails NZTA license testing.
- Any expenses other than course fees, incurred by NDTC, will only be refunded if NDTC is able to gain a refund on these expenses.

#### Postponement or Cancellation of a Course for a School or Community Organisation

Should you wish to postpone or cancel your attendance on a course or event organised for a School or Community Organisation, the following applies:

- Notification of any postponement or cancellation of course attendance must be made in writing to info@ndtc.co.nz
- If postponement or cancellation is given with more than seven working days' notice before the
  course or event date, the ticket buyer will be offered an alternative course or event date. A
  minimum \$25 transfer fee may apply for changes to booking dates and added to the new



booking. If no acceptable alternative dates are available to the ticket buyer, then a refund of full course fees less a \$50 administration fee may be given. All refunds are made at the discretion of NDTC.

- If notice is given with less than seven working days and greater than three working days before the course or event date, 50% of the course fee may be refundable. All refunds are made at the discretion of NDTC.
- All postponements or cancellations within three working days (including non-appearance or non-completion of the course or event) will result in full course fees being charged.
- If a client arrives to a course or event and is deemed to be of significant health or safety risk to themselves, others and or the instructor NDTC reserves the right to cancel the booking. An evaluation of the client will be carried out by NDTC, or approved representative of, using criteria of MPT Drug and Alcohol Policy to establish reasonable grounds. In this instance, no refund will be provided, and rebooking may be done on a case-by-case basis.
- If a client arrives more than 15 minutes late, they may be turned away and charges will still apply.
- A refund of NZTA application and/or testing fees, will not be provided in the instance that a ticket buyer does not provide correct documentation (such as driver licence) or fails NZTA license testing.

## Postponement or Cancellation of a **Driving Lesson**

Should you wish to postpone or cancel your driving lesson, the following applies:

- Notification of any postponement or cancellation of a driving lesson must be made in writing to info@ndtc.co.nz or by phoning 0800 555 055
- If postponement or cancellation of a driving lesson is given with more than three working days'
  notice before the driving lesson date, the ticket buyer will be offered an alternative driving
  lesson date. If no acceptable alternative dates are available to the ticket buyer, then a refund of
  the driving lesson fees less a \$10 administration fee may be given. All refunds are made at the
  discretion of NDTC.
- All postponements or cancellations advised one working day before the driving lesson (including non-appearance or non-completion of the lesson) will result in the driving lesson fees being charged.
- If a client arrives to a driving lesson and is deemed to be of significant health or safety risk to themselves, others and or the instructor NDTC reserves the right to cancel the lesson. An evaluation of the client will be carried out by NDTC, or approved representative of, using criteria of MPT Drug and Alcohol Policy to establish reasonable grounds. In this instance, no refund will be provided, and any rebooking will be on a case-by-case basis.

## Postponement or Cancellation by NDTC

Should NDTC cancel a course or event, the following applies:

• The ticket buyer will be offered an alternative course or event date with no transfer administration fee. If no acceptable dates are available to the ticket buyer, a full refund will be provided.

If you buy a ticket and you feel that you might have a legal right to receive a refund from the ticket seller you must immediately notify **NDTC** by emailing <a href="mailto:info@ndtc.co.nz">info@ndtc.co.nz</a> with booking reference number and relevant details.
